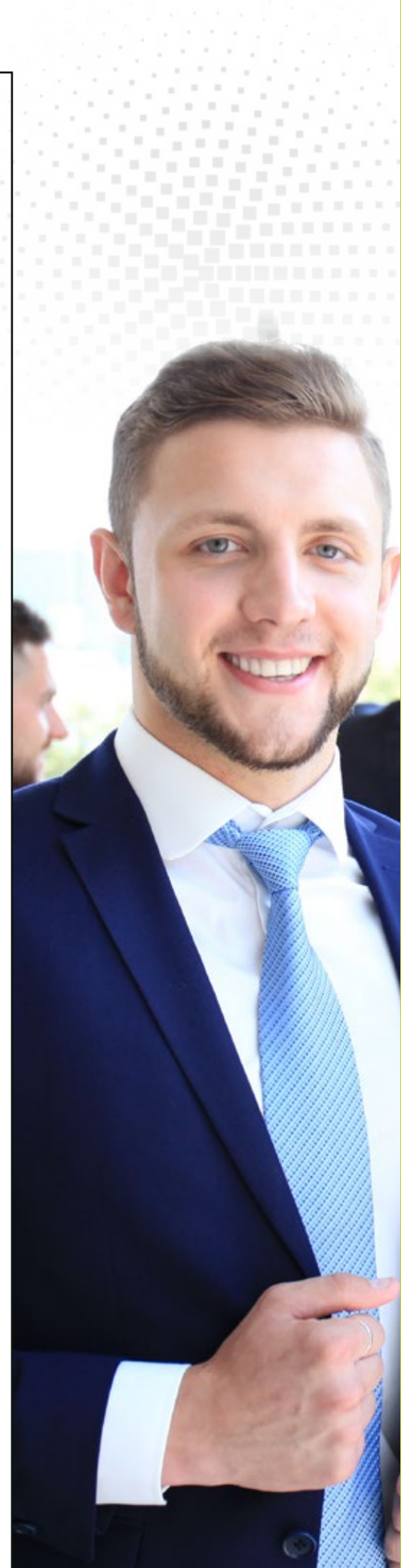

## HEALTH AND SAFETY POLICY / PROCEDURE / METHOD STATEMENTS

Companies with more than five employees are legally required to have a written workplace health and safety policy and formal arrangements to effectively manage workplace safety & health risks.

The policy shows that:

## FIRE SERVICES

### FIRE RISK ASSESSMENT

A fire risk assessment is an assessment of your premises, the activities carried on there and the likelihood that a fire could start and cause harm to those in or around the premises will be considered for the same.

The aims of the fire risk assessment are:

1. To identify the fire hazards.
2. To eliminate or reduce the risk of those hazards causing harm to as low as reasonable.
3. To decide what passive and active fire precautions and management arrangements are necessary to ensure the safety of people in your premises if a fire does start.

The overall objective of the risk assessment is to ensure the safety of the occupants of the building. In addition, Green World's competent staff may make recommendations on property protection.



### HOW LONG IS A FIRE RISK ASSESSMENT VALID FOR?

Under static circumstances this depends upon the risk profile of the property and appetite of the client to mitigate risk. Normally Green World would recommend a Fire Risk Assessment for a period of two years. However, it also depends on the facility for which the Fire Risk Assessment is being prepared. For example, Fire Risk Assessment conducted for properties such as blocks of flat can go up to three years or more. High Risk sites may need to be assessed annually.

## FIRE RISK AUDITS

Fire Risk audit is an effective tool for assessing fire safety standards of an organization or occupancy. A fire Risk audit addresses the inherent fire hazards associated with day to day activities in an occupancy and recommend measures to reduce the potential fire hazards. Also, it helps the people to identify the areas for improvement and evolve an action plan.

The methodology of conducting Fire Risk Audit or Fire Risk Assessment is based on the stage of construction or condition of the premises/facility at the time of audit. In general, the audit is conducted as described below:

1. Pre-audit data collection from site.
2. Site visit & study of existing facilities.
3. Review of documents available at site.
4. Testing of the fire safety equipment/systems & discussion at site.
5. Preparation of Fire Audit report.



## Testing Services

### -Noise Survey -Occupational Noise Monitoring

Occupational noise has been a constant threat since the birth of industry and occupational noise monitoring needs to be carried out to ensure that workers' hearing is protected from excessive noise at their place of work. All Employers are required to assess the risks to its employee's health and safety created by exposure to noise in the workplace.

One way of doing this is to carry out a workplace occupational noise monitoring survey. The results of this will aid the company in formulating its action plan to reduce exposures to noise, as required by regulations. These regulations state that companies are required to monitor noise levels in the workplace, and to take steps to prevent or reduce the exposure to noise risks.

Green World conducts accredited workplace noise assessments that include the 3 elements as required by the Control of Noise at Work Regulations 2005:

1. Static measurements to map and zone all significant noise sources
2. The measurement of personal exposure using dosimeters
3. Frequency analysis of major noise sources to determine the effectiveness of hearing protection provided.

Green World's experienced consultants undertake static mapping to provide a colour coded diagram and measure personal exposure using dosimeters plus:

1. Comprehensive workplace noise monitoring assessments to current standards

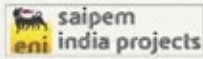
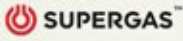
